A Corporate Member is entitled to one voting representative at the General Assembly. The annual fee is 10.000 Kuna.
BUSINESS MEMBER	Business Member is a legal entity registered in the Republic of Croatia or in one of the Nordic countries or any other legal entity, which in the view of the Board of Governors and Executive director fulfils the requirements to become a member of the Nordic Chamber of Commerce. (The annual worldwide turnover of a legal entity considered as a Business Member should be HRK 16 million or less). A Business Member is entitled to one voting representative at the General Assembly. The annual fee is 5.000 Kuna.

INSTITUTIONS AND NON-PROFIT ORGANIZATIONS	<b>Institutions and non-profit organizations</b> – legal entities registered in one of the Nordic countries or registered in Croatia and having Nordic background, which in the view of the Board of Governors and Executive director fulfil the requirements to become a member of the Nordic Chamber of Commerce. Institutions and non-profit organizations are entitled to <b>one voting representative at the General Assembly</b> .
PHYSICAL PERSON     INDIVIDUAL     MEMBER	A physical person (a citizen of a Nordic country or a Croatian citizen employed in a Nordic company/institution) can become an individual member of the Nordic Chamber of Commerce in Croatia, if the Board of Governors on the proposal of Executive director decide so. Individual member is entitled to one vote at the General Assembly. Individual member does not belong to any of the membership categories mentioned above. The annual fee is 1.000 Kuna.
